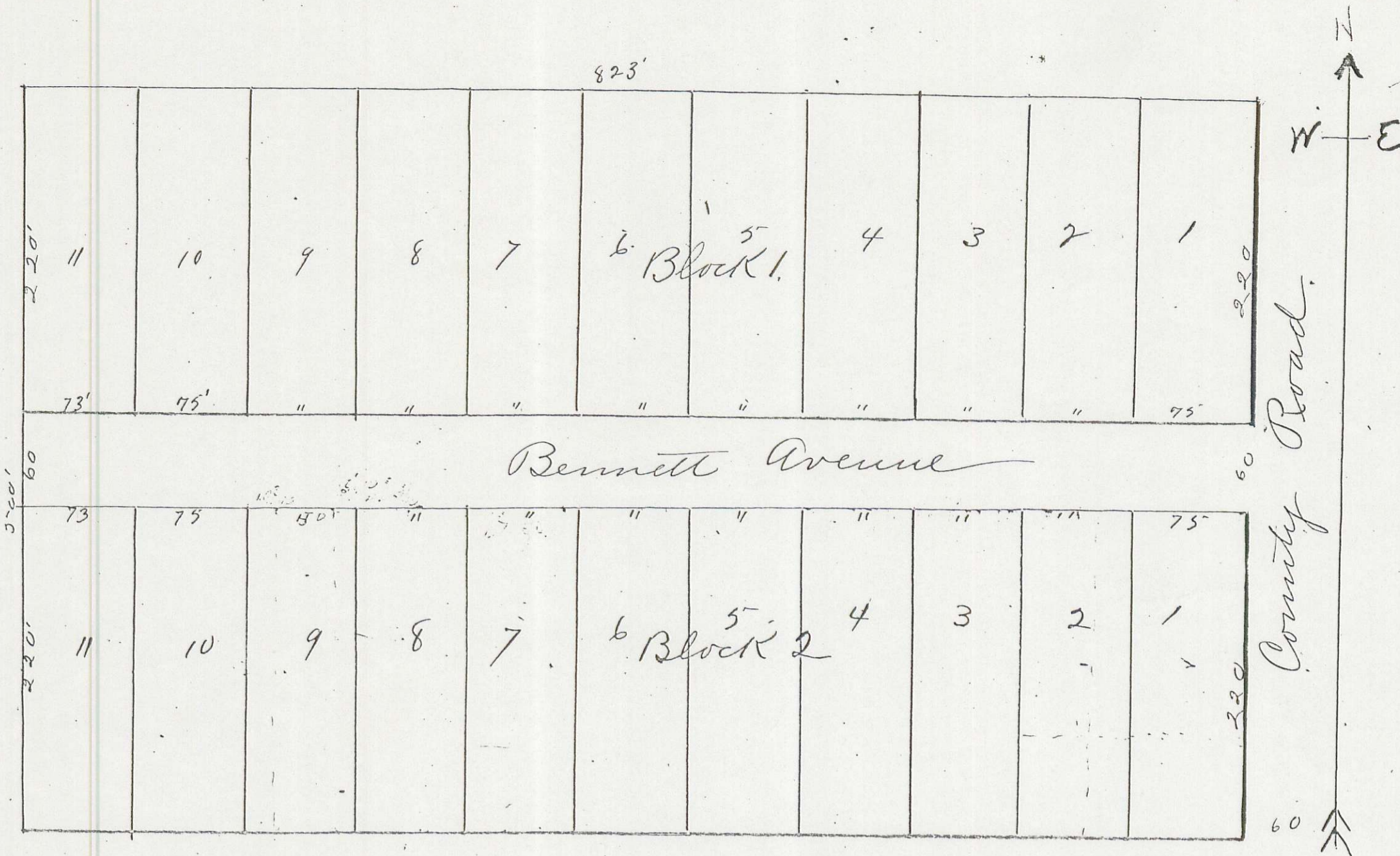


Sunrise Home Park.



Description

The outside boundaries of the Sunrise Home Park: as shown on the map hereon are as follows, to-wit - Beginning at a point on the West boundary of the County Road 20 feet west and 1250 feet north of the South East corner of Donation claim number 42 in Township 37 South, Range West of Willamette Meridian, State of Oregon, and Section 19, and from said point running thence North along the West boundary of the County road 500 feet; thence West 823 feet; thence South 500 feet; thence East on the North boundary of the above tracts 23 feet to the place of beginning the said tract having been surveyed into Blocks, Lots, and Streets as shown by the map hereon.
