DESCRIPTION:- From a point of the intersection of the centers of Ross Court and Main Street West run west on center line of Main Street 172.59 feet; thence north 30 feet to point of beginning. Thence run north 758.8 feet to south line of Fourth St. West; thence west on said south line 286.5 feet; thence south 618.8 feet; thence east 113 feet; thence south 140 feet; thence east 173.5 feet to point of beginning.

DEDICATION:- Know all men by these presents that we E. B. Pickel, and Mattie E. Pickel (his wife), and B. Klum and Florence Klum (his wife) and W. C.
