DESCRIPTION:
Commencing 58 feet East and 538 ft. North of the N. W. Corner of D.L.C.No.85 Twp 37 S.R.2 W:W.M. thence North 792.2 ft. to the S.E. Cor of Blk. 2 of Barr's Addition to Medford, Ore. and intersecting the South end of K Street of said City, thence East 60 ft.; thence North 30 ft.; thence East 746 ft. to the center line of Oakdale Ave.; thence South 50 ft; thence West 316 ft; thence South 772.2 ft. to the North line of Belmont Ave; (heretofore dedicated to Jackson County for a public highway) thence West 490 ft. to the place of beginning, excepting and reserving Dakota Avenue.

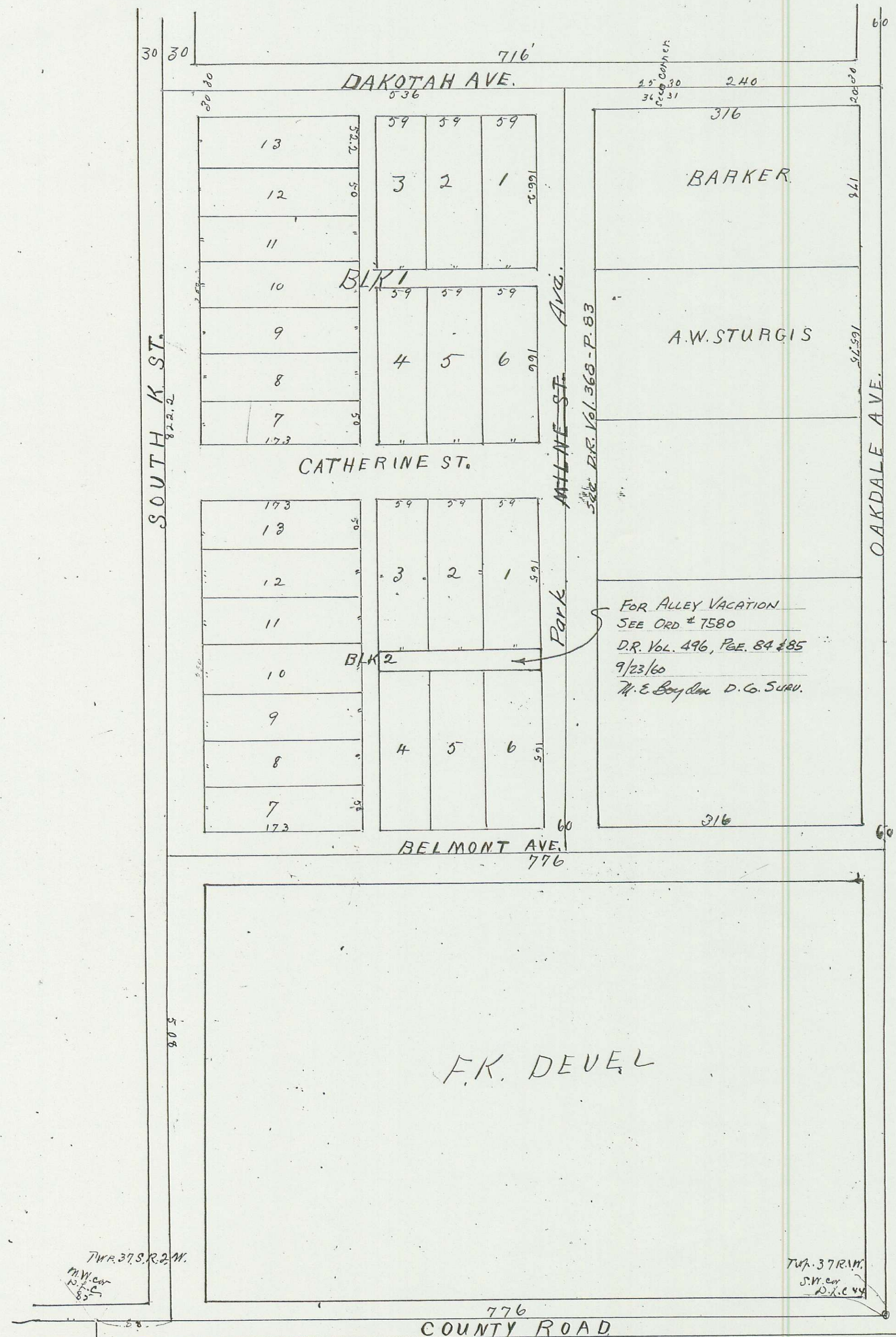
