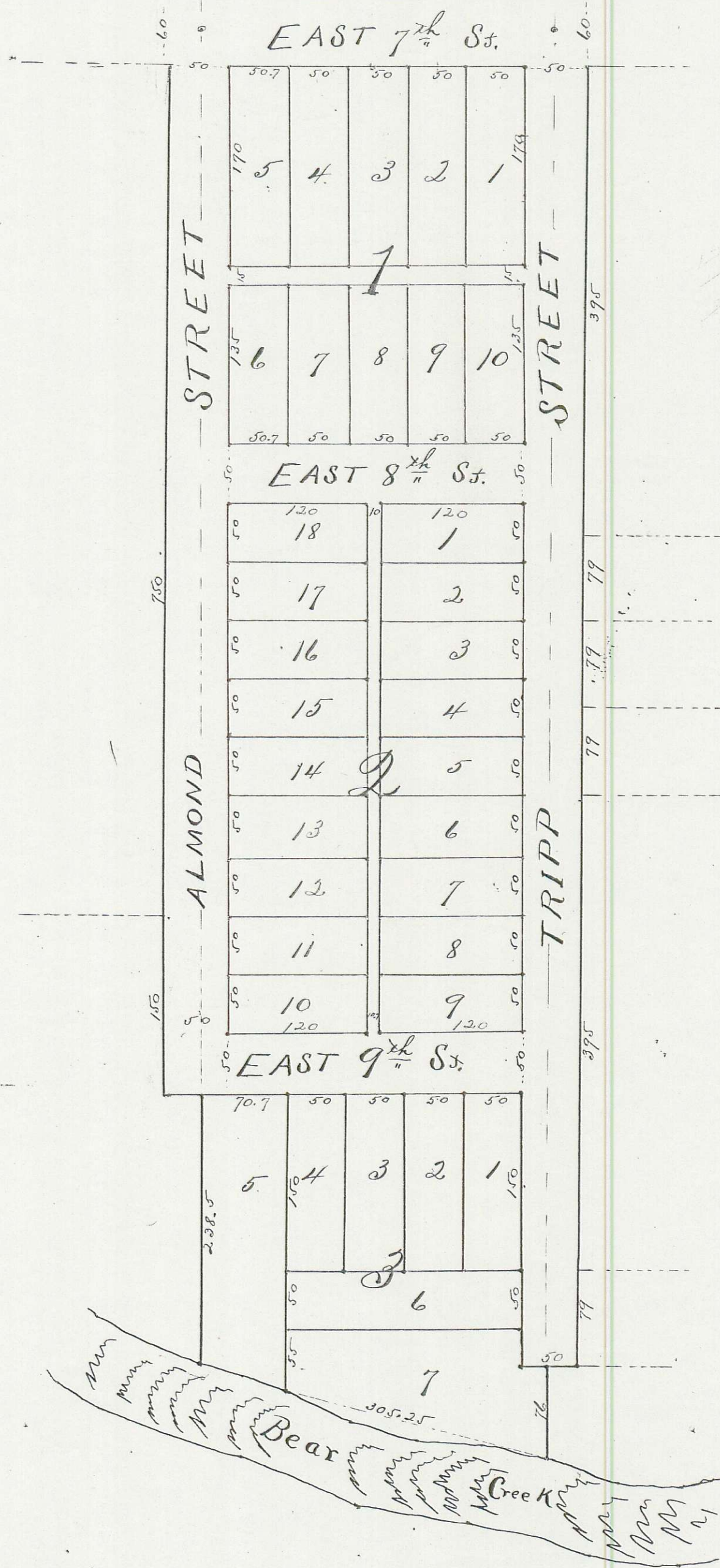

I, Carl T. Jones of Jackson County, Oregon, do hereby certify that on the 24th day of Feb., 1905, I surveyed the following described tract of land, to-wit: Commencing at a point on the north boundary of the N. B. Evans Donation Claim number 44 in Township 37 South Range I West of Willamette Meridian; 16.91 chains West of the South East corner of Donation Claim number 42 and running thence South 18.37 chains to the North bank of Bear Creek, thence N. 76° W. 4.62 chains to a point in the creek, thence North 17.25 chains, thence East on north boundary of Claim 44, 4.48 chains to the place of beginning. That I laid the same out into Blocks, Lots, Streets and Alleys as represented upon the Map hereto connected; the numbers of said Blocks and Lots are indicated by figures near the center thereof respectively, and the dimensions of said Lots are indicated by figures denoting feet near the boundaries thereof; and that the Map is a full, true and correct representation of said survey.
