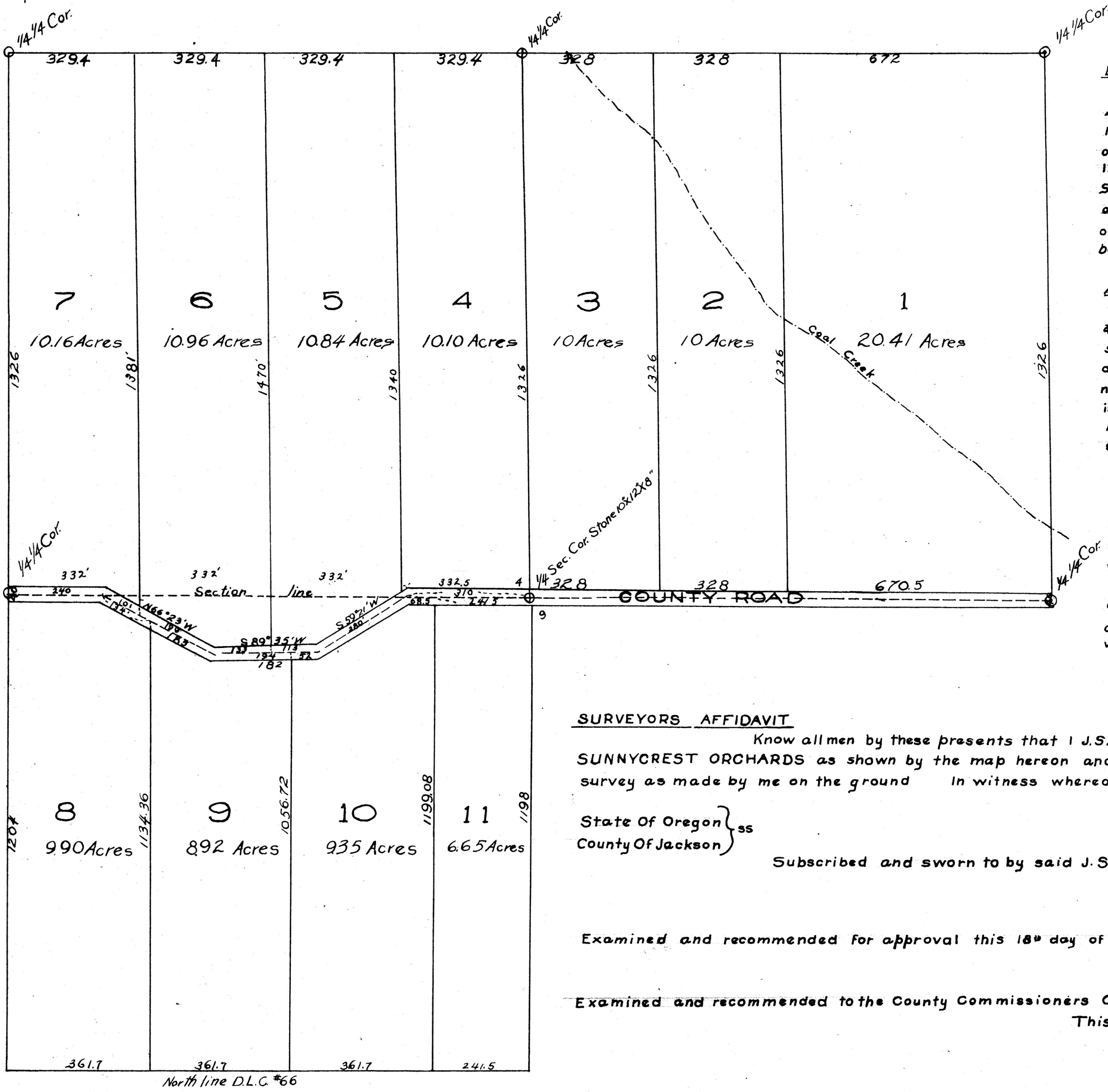


SUNNYCREST ORCHARDS

Description
Commencing at the 1/4 Sec. corner between Sections 4 and 9 Twp. 37 S. R. 1 W. of the W.M. at which corner I set a stone 12'x10'x6" as required by Law and running thence S. 89° 49' E. on the section line 1326.5 feet to the 1/4 1/4 cor. thence North 1326 feet; thence West on the 1/4 1/4 line 2645.5 ft. to the 1/4 1/4 Sec. corner thence South 2530 ft. to the North line D.L.C. #66 aforesaid Twp. and Range; thence East along North line of said Claim 328.5 ft.; thence North 1198 ft. to the place of beginning
