

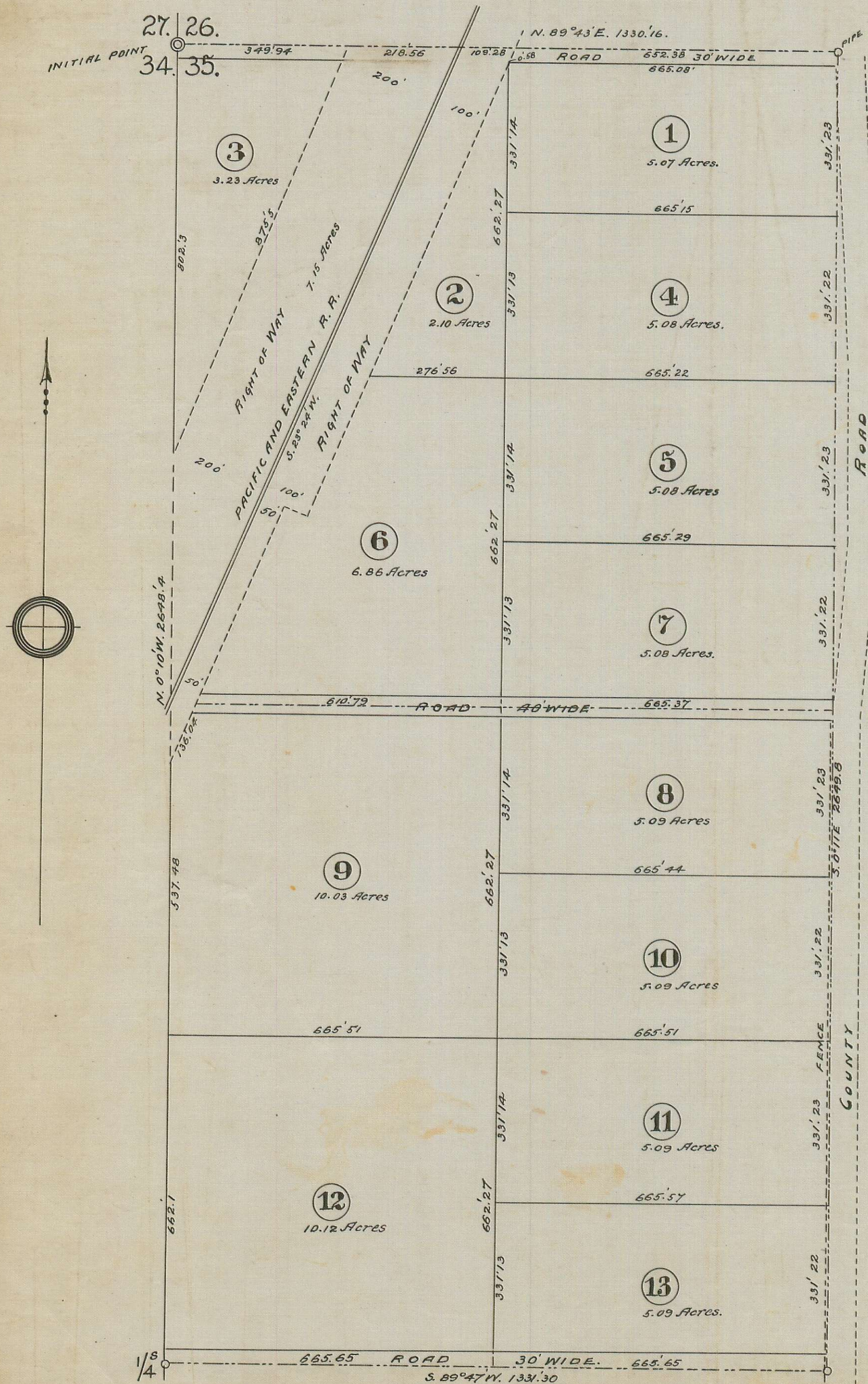
MOUNTAIN VIEW TRACT NO. 1.

DESCRIPTION Beginning at the common corner to Sections 26, 27, 34 and 35, Township 35 South, Range 1 West, Will. Mer; thence N. 89° 43' E. 1330.16 feet on line between Secs 26 and 35; thence S 0° 11' E. 2649.8 feet; thence S. 89° 47' W. 1331.30 feet to 1/4 Section corner between Secs. 34 and 35; thence N. 0° 10' W. 2648.4 feet to place of beginning, being the W. 1/2 of N. W. 1/4 of Section 35 Township 35 South, Range 1 West.

DEDICATION: Know all men by these presents, that we J. F. Brown and A. H. Brown his wife of Jackson County, State of Oregon, are the owners in fee simple of the above described tract of land; that we have laid out the same into Tracts and Roads, as shown by the map hereon, and that said map is a correct representation of the survey and sub-division, and that we do hereby dedicate to the public for public highways, all the streets or roads shown on said tract, and we do hereby designate and name the said tract as shown hereon as **MOUNTAIN VIEW TRACT NO. 1.**
