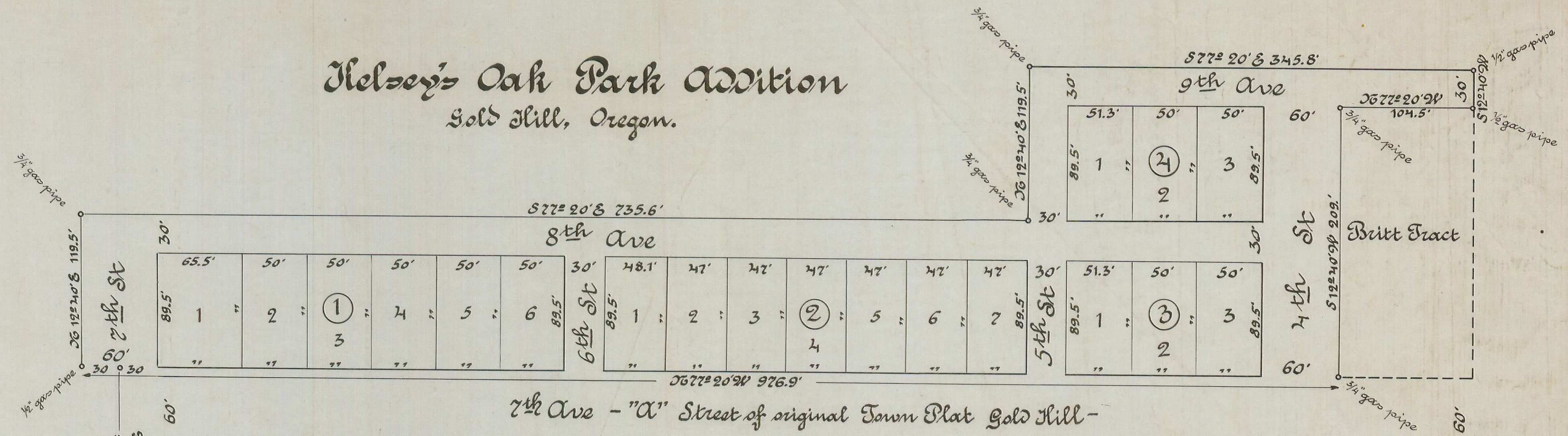


Helsey's Oak Park Addition

7th Ave - "A" Street of original Town Plat Gold Hill -

Original Town Plat Gold Hill

Commencing at the section corner common to sections 15, 16, 21 and 22 Twp. 36 South Range 3 West, Jackson County Oregon, and running thence South 77° 20' East 84.3 ft to the center of 7th Street - designated 1st Street in Original Town Plat of Gold Hill - thence running North 12° 40' West along the center line of said street 770.37 ft to a point on the North line of 7th Ave - designated "A" Street in Original Town Plat of Gold Hill - thence running North 77° 20' West along the North line of 7th Ave 30 ft to the place of beginning: thence running North 12° 40' East 119.5 ft: thence South 77° 20' East on a line parallel to 7th Ave 735.6 ft: thence North 12° 40' East 119.5 ft: thence South 77° 20' East 345.8 ft: thence South 12° 40' West 30 ft to the North boundary of the Britt Tract: thence North 77° 20' West 104.5 ft along the North boundary of the Britt Tract: thence South 12° 40' West along the West boundary of the Britt Tract to a point on the North line of 7th Ave 209.0 ft: thence South 12° 40' West along the line of 7th Ave. 976.9 ft to the place of beginning and containing 3.41 Acres.

I know all men by these presents that we, R. C. Helsey and Flora A. Helsey, husband and wife, are the owners in fee simple of the above described tract, and that we have subdivided the same into lots, blocks and streets as shown by the map hereon and on which the number and size of the lots and the lengths of all lines are plainly set forth, and all other matters appertaining to the subdivision of said tract are shown on the map, and we do hereby dedicate to the public for public use all roads shown hereon, and we hereby designate said tract as "Helsey's Oak Park Addition" to the town of Gold Hill and have so named it on the map hereon.
