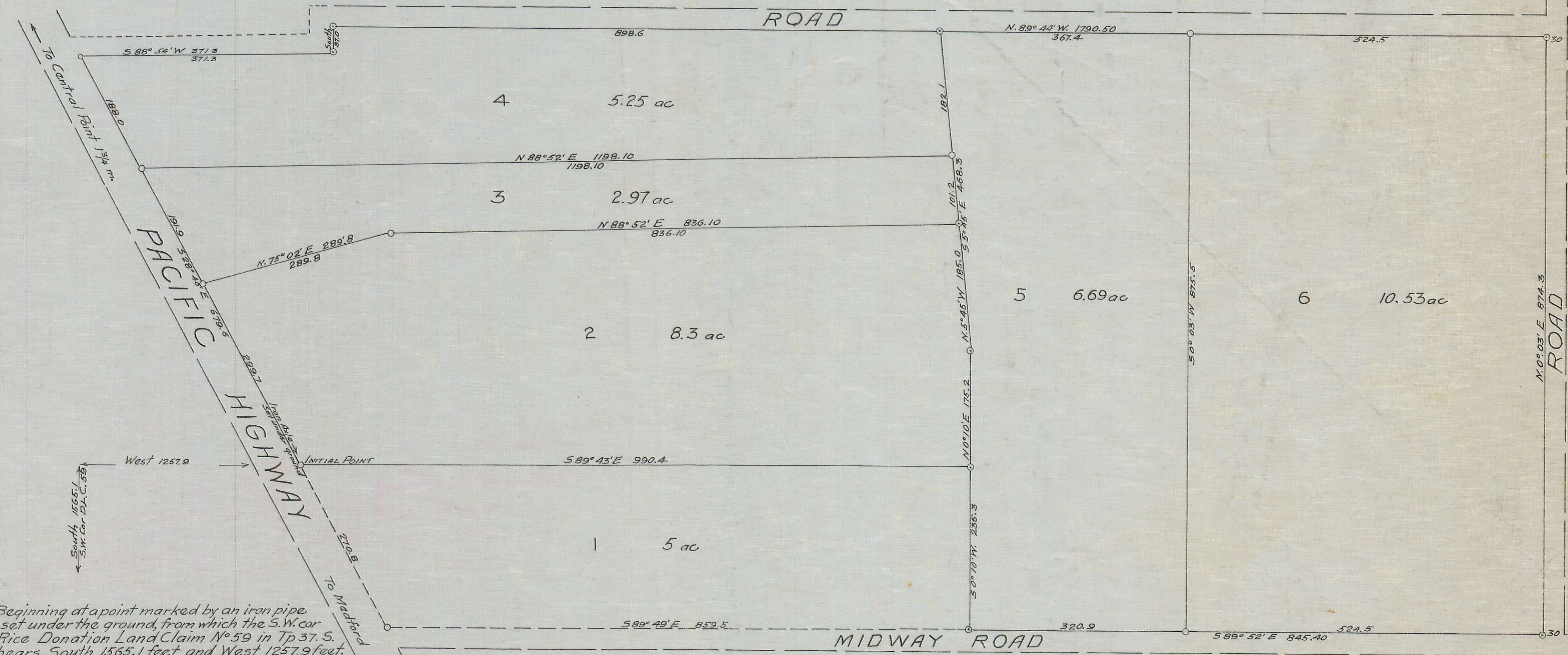


— MIDWAY SUBDIVISIONS —

DESCRIPTION. Beginning at a point marked by an iron pipe, 3" in diameter set under the ground, from which the S.W. cor of the Levi A. Rice Donation Land Claim No. 59 in Tp 37. S. R. 2. W. W. M. bears South 1565.1 feet and West 1257.9 feet, running thence, S 89° 43' E 990.4 feet, thence S 0° 10' W 235.3 feet to North side of MIDWAY ROAD, thence S 89° 52' E 845.4 feet along North side of said Midway Road, thence N 0° 03' E 874.3 feet along West side of road, thence N 89° 44' W 1790.5 feet, thence South 37.0 feet, thence S 88° 54' W 371.3 feet to Northeast side of PACIFIC HIGHWAY, thence S 28° 40' E 679.6 feet to the place of beginning.

DEDICATION. Know all men by these presents that we, Albert Clifton Taylor and Irma Taylor husband and wife, of Jackson County, State of Oregon, are the owners in fee simple of the above described tract of Land, that we have laid out the same into lots, as shown by the map hereon, and that said map is a correct representation of the survey and subdivision, and we do hereby designate and name the said tract as shown hereon as the MIDWAY SUBDIVISION.
