DESCRIPTION.

HILLSIDE ADDITION TO EDGEWOOD PARK is a subdivision of Lot 2, Section 16 Twp 34 S. R. 1 W. W. M. and is more particularly described as follows:

Beginning at an iron pipe which stands on the South line of Section 16. 1311 feet West of the corner to Sections 15, 16, 21 and 22 Twp 34 S. R. 1 W. W. M. Thence S 89° 45' W 1330.6 feet to the 1/4 Section corner between Sections 16 and 21; Thence N 0° 15' W 1290 feet to a stake; Thence N 89° 45' E 1624 feet to a stake on the right bank of Froque River; Thence continuing N 89° 45' E 26 feet to the low water mark; Thence following down the meander line at low water mark S 26° 30' W 335.4 feet; Thence S 11° 20' W 700 feet; Thence South 305 feet to the South line of Section 16; Thence S 89° 45' W 26.0 feet to the place of beginning.

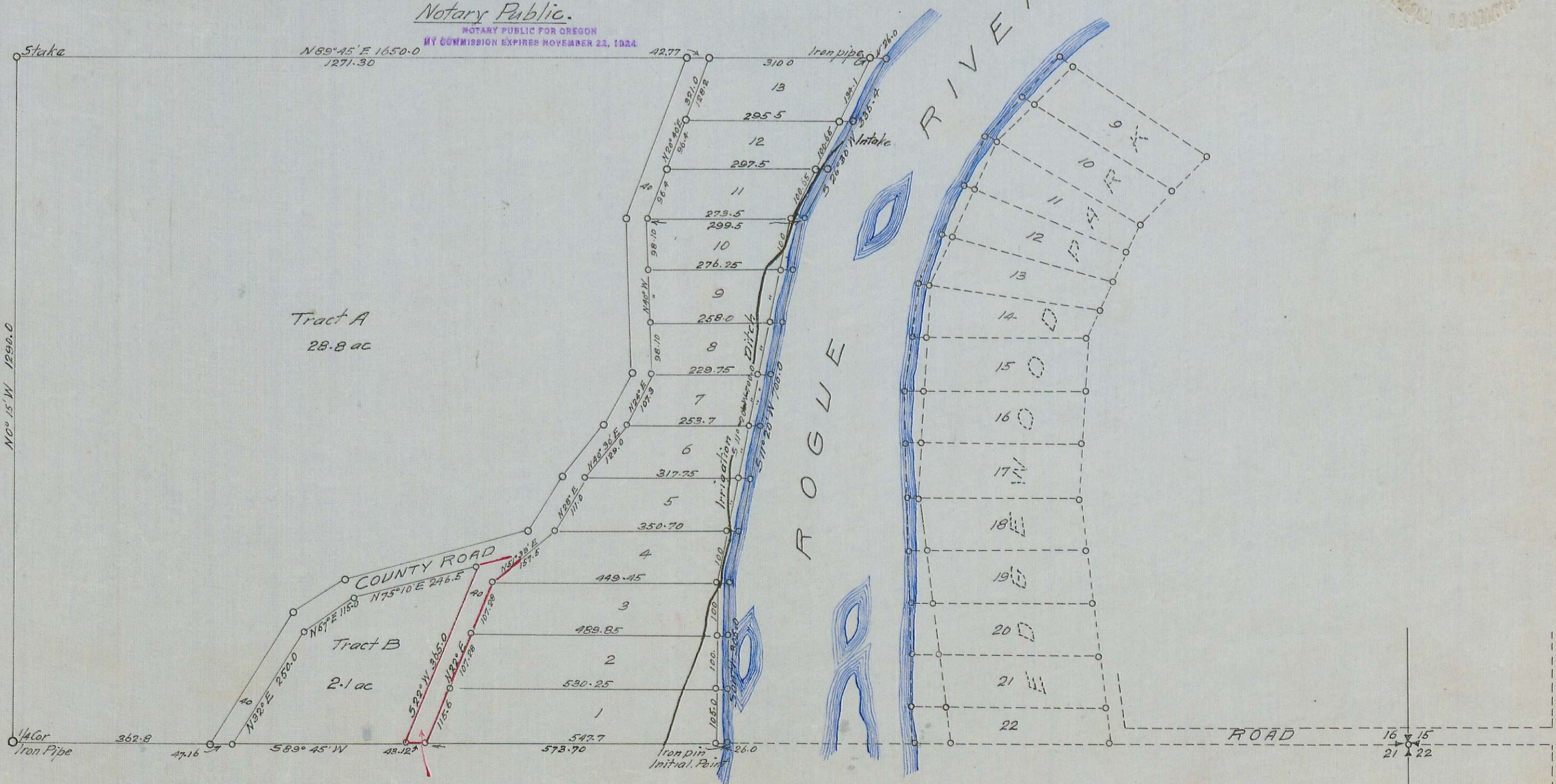
