Beginning at a section corner common to Sections twenty (20), twenty one (21), twenty eight (28) and twenty nine (29) in Township 37 South Range One (1) West of the Willamette Meridian; running thence South 89° 58' West along the section line 984.36 feet to a 2" pipe set in concrete; thence North 596.54 feet to a 2" pipe set in a concrete block 12" x 12" x 18"; thence North 89° 58' East 987.37 feet to the section line; thence South 0° 17' West 596.54 feet along the section line to the point of beginning.

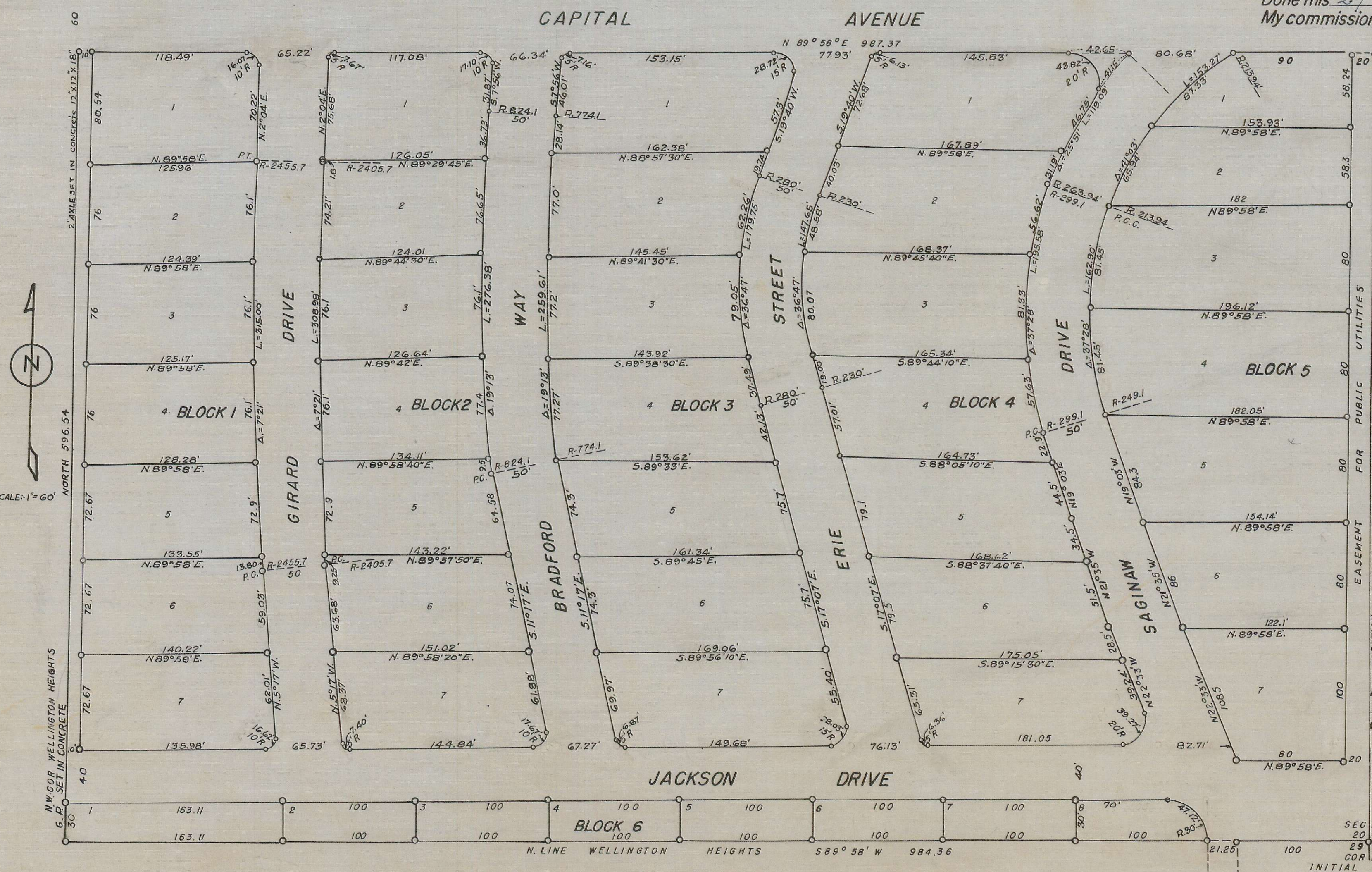

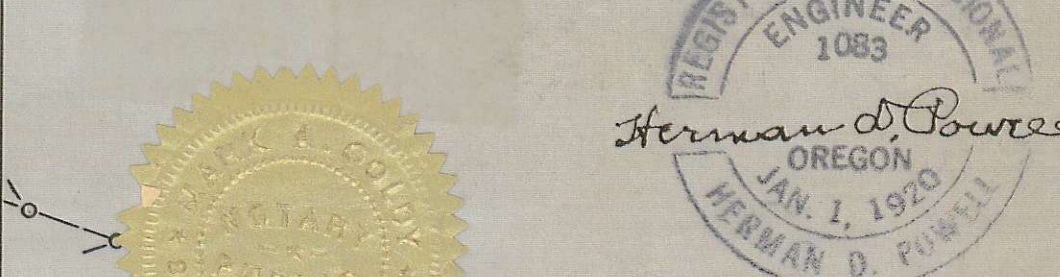
