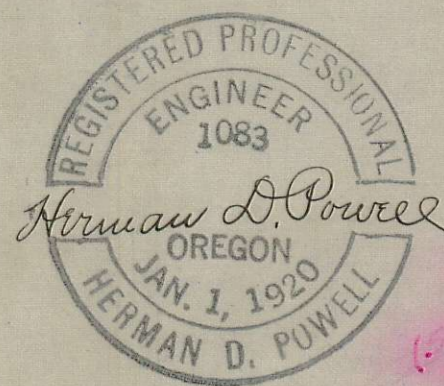
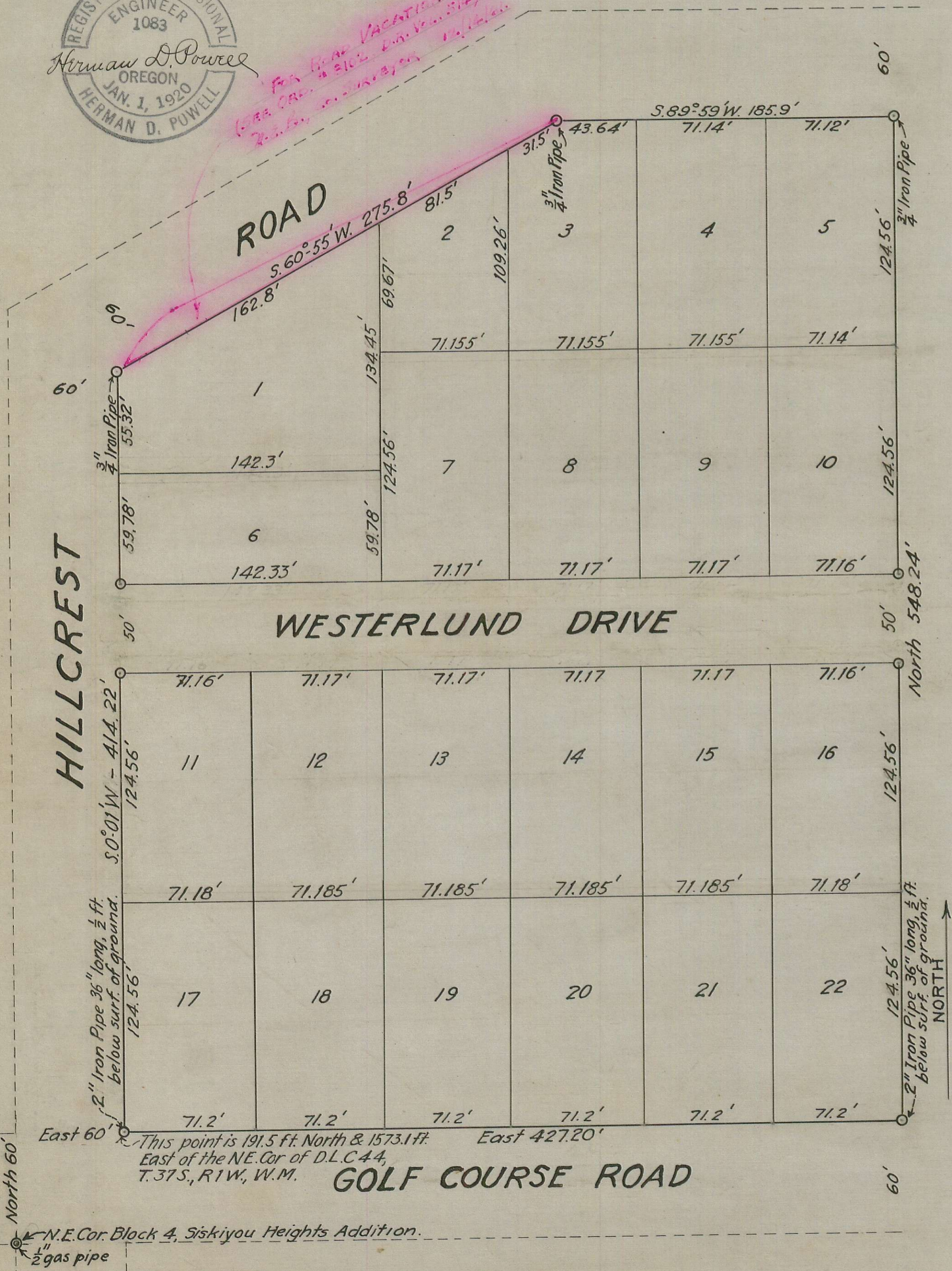


WESTERLUND HEIGHTS ADDITION TO THE CITY OF MEDFORD, OREGON

DESCRIPTION

Commencing at a 2 inch iron pipe 36 inches long 1/2 foot below the surface of the ground, which is 60 feet North and 60 feet East of the N.E. Corner of Block 4, Siskiyou Heights Addition to the City of Medford, Oregon, thence East 427.2 ft. to a 2 inch iron pipe 36 inches long, 1/2 foot below the surface of the ground, thence North 548.24 ft., thence S. 89° 59' W. 185.9 ft., thence S. 60° 55' W. 275.8 ft., thence S. 0° 01' W. 414.22 ft. to the point of beginning.

DEDICATION

Know all men by these presents that I, Ella C. Westerlund am the owner in fee simple of the above described tract, and that I have subdivided the same into lots and streets as shown hereon; and the number and size of the lots, and the length of all lines are plainly set forth, and that this plat is a correct representation of said subdivision, and I do hereby dedicate to the public for public use, all streets shown hereon; and I hereby designate said subdivision as Westerlund Heights Addition to the City of Medford, Oregon, and have so named it on the map hereon.
