No. 12 in Twp. 37 S., R. 12 W., M. 19, thence West 332.0 feet thence South 10° 30' E. 317.2 feet thence 54° 30' E. 451.5 feet thence North 66.0 feet thence East 5.0 feet thence North 454.0 feet thence West 30 feet to place of beginning.

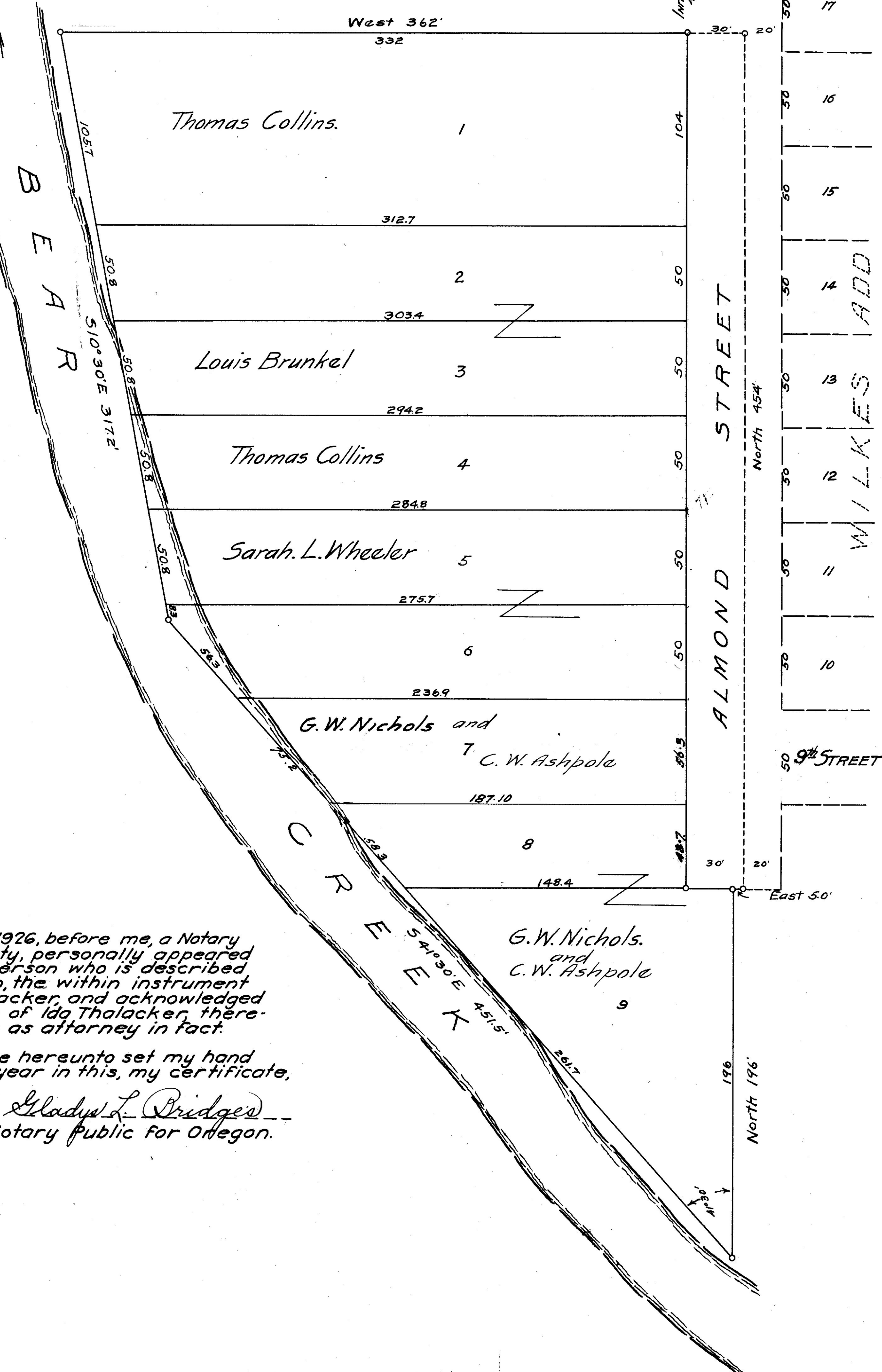
