
AMENDED PLAT OF BLOCKS 7 AND 8 SOUTH PARK ADDITION TO MEDFORD OREGON

DESCRIPTION

Commencing at the Southeast Corner of Block 8, South Park Addition to Medford, Oregon, said point being further described as being 1030.7 feet North, and 1844.99 feet East of the Southwest Corner of Donation Land Claim No. 44, Township 37 South, Range I West of the Willamette Meridian, in Jackson County, Oregon, and from said point running thence West 528.0 feet to the Southwest corner of Block 7, thence along the West line of Block 7, North 630.0 feet to the Northwest corner of Block 7; thence along the North line of said Block 7 East 82.5 feet to the Westerly line of South Holly Street; thence South 35°20' East along the said Westerly line of the Street, also the Northeasterly line of said Blocks 7 and 8, 770.42 feet to the place of commencing, being all of said Blocks 7 and 8 of South Park Addition, the alley in said Block 7, and Alta Street, lying between said Blocks.
