DESCRIPTION

Commencing at an initial point a 1 1/2" iron pipe embedded in concrete which bears S89°58'W 99.25 feet from the section corner common to Sections (20), (21), (28), (29), in Township 37 South of Range (1) West of the Willamette Meridian, thence S89°58'W 885.11 feet to a 1 1/2" iron pipe embedded in concrete, thence S0°10'E 402.30 feet to a 1 1/2" iron pipe embedded in concrete, thence N89°48'E 885.11 feet along the North line of Hillcrest Road to a 1 1/2" iron pipe embedded in concrete, thence N0°10'W 399.60 feet to the point of beginning
