DESCRIPTION: Commencing at the N.W. Corner of Donation Land Claim N° 52 T₃₇S. R₁. W.W.M. marked by an iron pin. Thence following along the North line of said D.L. Claim S₈₉° 54' E. 1512.68 feet to a point on line marked by an iron bolt. Thence S₀° 17' W. 278.0 feet to a point marked by a 2"x36" Galv iron pipe, the INITIAL POINT of this survey, and the North East corner of this tract. Thence S₀° 17' W. 278.8 feet to a point marked by a 3/4"x24" Galv iron pipe the South East corner of this tract. Thence N₈₉° 43' W. 188.7 feet, marked by a 3/4"x24" Galv iron pipe the South West corner of this tract. Thence N₀° 17' E. 278.8 feet to a point marked by a 2"x36" Galv iron pipe the North West corner of this tract. Thence S₈₉° 43' E. 188.7 feet to the North East corner of this tract and the point of beginning.
