Commencing at the N.W. Cor. of D.L.G. 52 TWP. 37 S. R. 1 W. M. M. and running thence S. 89° 55' E. 209° Feet; thence S. 0° 18' W. 20° Feet to the Place of Beginning, marked by a 2" x 36" Galv. Iron Pipe; thence S. 89° 55' E. 388° Feet to a 1/2" x 30" Galv. Iron Pipe; thence S. 0° 18' W. 552° Feet to a 1/2" x 30" Galv. Iron Pipe; thence N. 89° 44' W. 388° Feet to a 3/4" x 30" Galv. Iron Pipe; thence N. 0° 18' E. 552° Feet to the Place of Beginning.
