KNOW ALL MEN BY THESE PRESENTS; that we Dr. R. P. Mortensen and Alma S. Mortensen, his wife, being the owners in fee simple, of the lands here-on described, have caused said lands to be surveyed and set apart for cemetery purposes all of which is correctly shown by plat here-on, and said cemetery is designated SISKIYOU MEMORIAL PARK.

We hereby reserve Fairview Drive 18 feet in width together with all 3 feet walks here on shown, for use in connection with the operation of said park for cemetery purposes. IN WITNESS WHERE-OF, we have here-unto set our hands and seals this the 31 day of January 1931.

## SURVEYORS CERTIFICATE

State of Oregon, S.S.

I, C. Z. Boyden, being first duly sworn this 30th day of January 1931, do hereby certify that I have correctly surveyed and marked with proper monuments the tract of land here-on shown and said plat is a correct representation of said survey as made by me on the ground. That I planted a proper monument as provided by law, to wit: A two inch by thirty six inch galvanized pipe set six inches below the surface of the ground indicating the initial point of said survey, the same being located as follows; Commencing at the North east corner of D. L. C. #50, Township 37 South, Range 1 West, Willamette Meridian as established by United States survey, thence North 985.3 feet; thence West 117.1 feet to the Northwest corner Block 24, Extension of Siskiyou Heights Addition to the City of Medford, the same being said Initial point, and the following is an accurate description of the tract of land on which said lots and Blocks are located; From said Initial Point; thence 589°33'E, 161.9 feet to the P.C.; thence following the arc of an 1861.5 feet radius curve to the left 203.6 feet to the P.T.; thence N84°11'E, 20.78 feet; thence 57°45'E, 223.15 feet to the intersection of a 510.23 feet radius curve to the right; thence following the arc of a 510.23 feet radius curve to the right 120.5 feet to the P.C.C.; thence following the arc of a 170.0 feet radius curve to the right 111.92 feet to the P.T.; thence N48°33'W 165.5 feet; thence N89°33'W 70.6 feet; thence

N0°17'E; 64.75 feet to the Initial Point.
