Beginning at an Iron Pipe 2" x 36", 1/2' below the surface of the ground for the Initial Point of this survey, said point bears N0°40'W 20.0' from an Iron Pin at the 1/4 Corner of Sections 15 & 22, T.36.S.R.4 W.W.M., Thence N0°40'W 275.68' to a 2" Iron Pipe, Thence S89°20'W 8.0', Thence N0°40'W 7.5' to a 3/4" Iron Pipe, Thence S89°20'W 122.0' to a 3/4" Iron Pipe, Thence S0°40'E 7.5' to a 3/4" Iron Pipe, Thence S89°20'W 17.5' to 1/4" Iron Pipe, Thence S0°40'E 275.68' to a 1" Iron Pipe, Thence N89°20'E 147.5' to the point of beginning.
