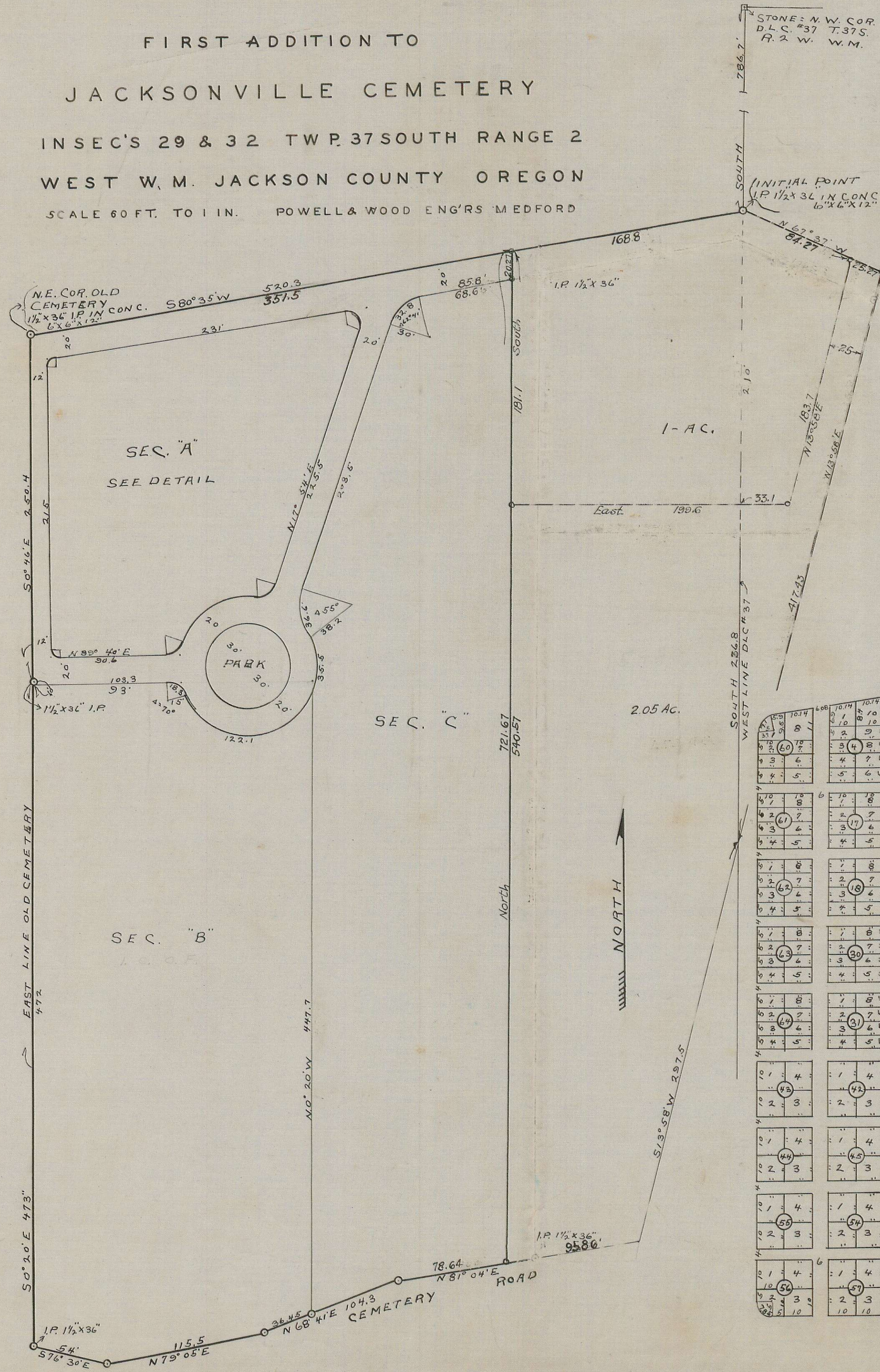


FIRST ADDITION TO

DESCRIPTION

Beginning at an Iron Pin on West line of D.L.C. No. 37 in Twp. 37 South Range 2 West W.M. and South on said line 786.7 feet from the Northwest Cor. said D.L.C.; Thence S. 80° 35' W. 520.3 ft. to an Iron Pin at Northeast Corner old Cemetery; Thence S. 0° 46' E. 250.4 ft. and S. 0° 20' E. 473 ft. along East line old Cemetery; Thence S. 76° 30' E. 54 ft.; N. 79° 05' E. 115.5 ft.; N 68° 41' E. 104.3 ft. and N. 81° 04' E. 78.64 ft. along North line Cemetery Road; Thence North 721.67 ft.; thence N 80° 35' E. 168.8 ft.; thence S 67° 37' E. 106.93 ft.; thence N 13° 58' E. 20.22 ft.; thence N 67° 37' W. 109.54 ft. to place of beginning.

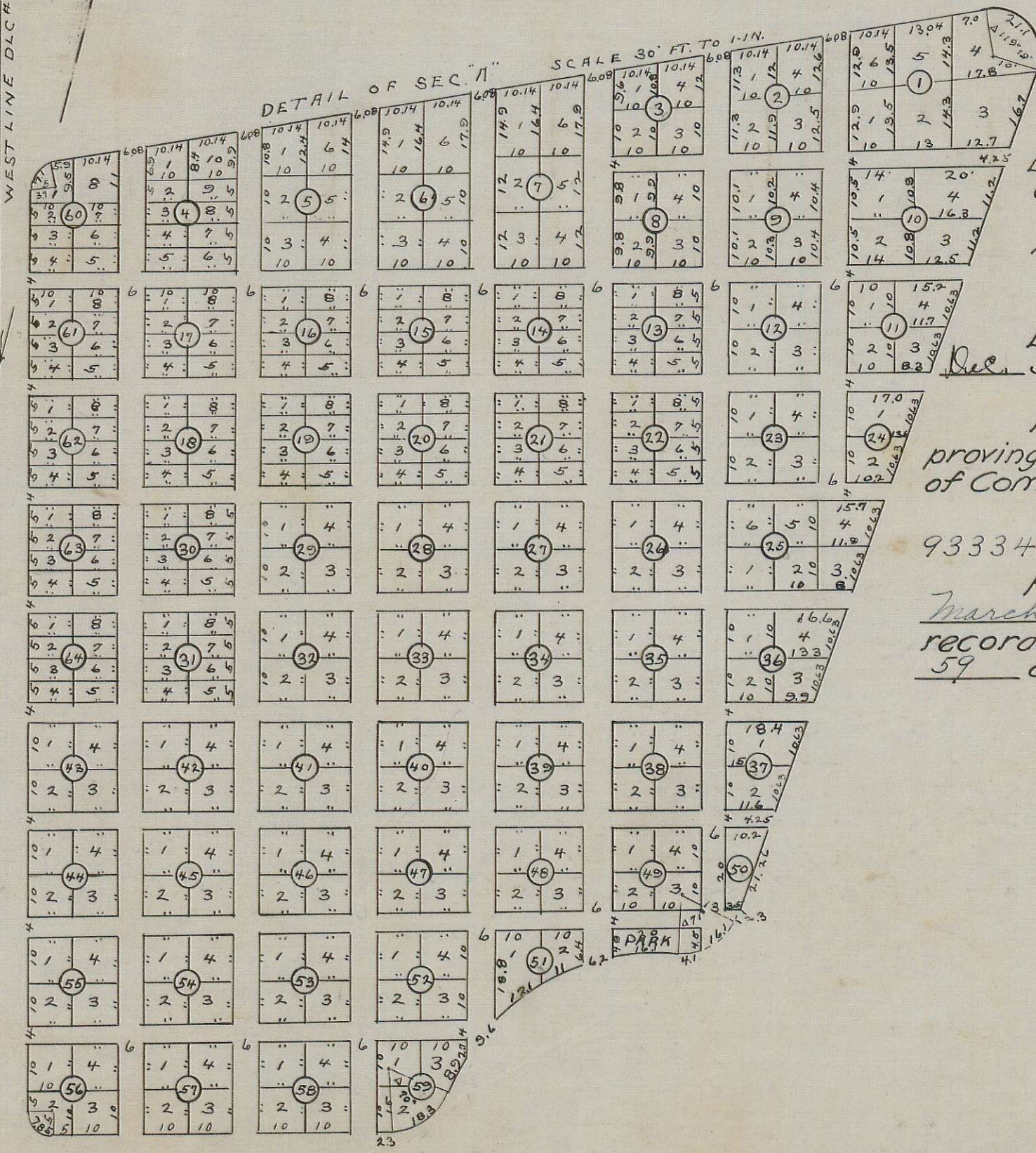
DEDICATION

KNOW ALL MEN BY THESE PRESENTS, that the City of Jacksonville, Jackson County Oregon, is the owner in fee simple of the tract described hereon, and that it has through resolution of the City Council on September 1st 1931, subdivided the same for Cemetery purposes into Lots, Blocks, Drives and Walks as shown hereon. That the number and size of the lots and the length of all lines are plainly set forth and this plat is a correct representation of said Cemetery. That the drives and walks, as shown hereon, are hereby dedicated to the use of the Public, and that this Cemetery is hereby designated as First Addition to Jacksonville Cemetery.
