



DESCRIPTION.  
Beginning at a point which is East 1257.2 feet and North 0°26' East 460.0 feet from the quarter section corner common to Sections 16 and 17, in Township 37 South, Range 2 West of the Willamette Meridian, and from said point running thence North 0°26' East 1040.84 feet; thence East 300.94 feet to the West

line of tract described in Deed Records, Volume 188, Page 433; thence South along the West line of last described tract 654.4 feet to the South West corner thereof; thence N. 88° 55' E. 31.44 feet to an iron pin set in concrete; thence N. 88° 55' E. 571.8 feet to an iron pin set in concrete, said pin being 5.0° 02' E. 702.9 feet and West 16.5 feet from the N. W. corner of D.L.C. #43, said 1p. and Range; thence S 0° 02' E. 595.0 feet; thence East 16.5 feet to the W. line of said D.L.C. #43; thence S 0° 02' E. along the D.L.C. line 350.1 feet to the North line of tract described in Deed Records Volume 177, Page 187; thence along the N. line of last described tract N. 89° 02' W. 518.4 feet to the S.E. corner of tract described in Registered Title 4625; thence along the Easterly line of last described tract as follows: N 10° 32' E. 58.3 feet; N. 22° 57' W. 161.5 feet; N. 11° 30' W. 245.5 feet; N. 22° 47' E. 36. feet; N. 7° 26' E. 95.6 feet; N. 2° 00' E. 21. feet to the North line of last described tract; thence N 88° 58' W. 414.6 feet to the point of beginning.
