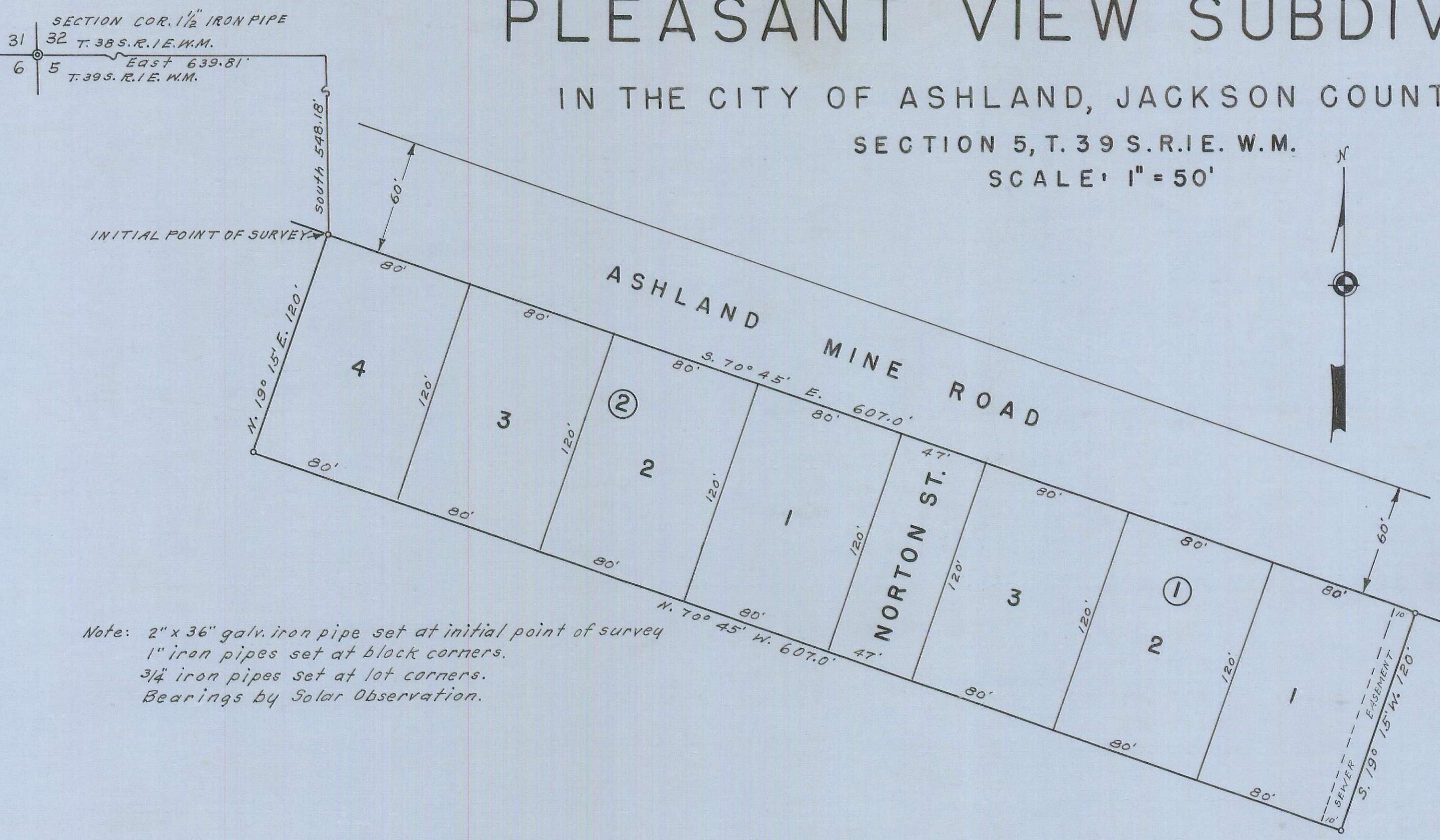


PLEASANT VIEW SUBDIVISION

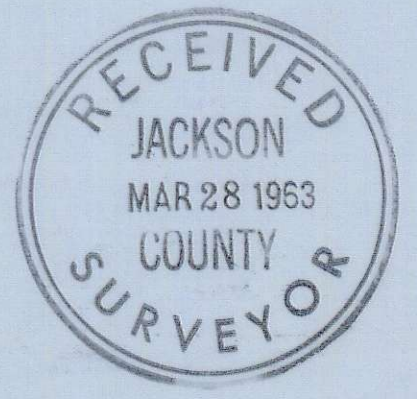
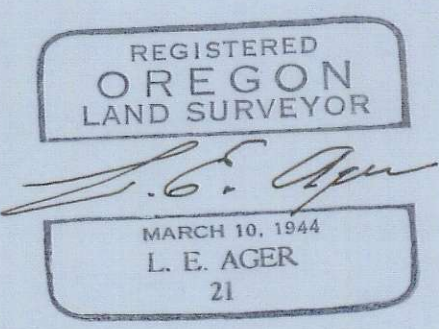

I, L.E. Ager a duly registered Surveyor of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines; Beginning at a point on the Southwesterly side line of the Ashland Mine Road in Section 5, Township 39 South, Range 1 East of the Willamette Meridian, Jackson County, Oregon, which point bears 639.81 feet East and 548.18 feet South of the Northwest corner of said Section; thence along said road, S. 70° 45' E. 607.0 feet to the Northwest corner of tract conveyed to Joseph Platco, Jr. thence S. 19° 15' W. along the Westerly line of said tract, 120.0 feet; thence N. 70° 45' W, parallel with the Ashland Mine Road, 607.0 feet; thence N. 19° 15' E. 120.0 feet to the point of beginning.
