SURVEYOR'S CERTIFICATE

Verlyn Thomas, a duly registered Surveyor of the State of Oregon, being first duly sworn do hereby certify that I have correctly surveyed and marked with proper monuments as provided by law the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines:

Beginning at a concrete monument with metal tablet set at the Southwest corner of Easy Valley Subdivision, said monument being South 89°39' East 66.33 feet and South 0°05'10" West 1115.23 feet from the Southeast corner of Donation Land Claim No. 39, Township 38 South, Range 2 West, Willamette Meridian, Jackson County, Oregon; thence along the south line of Easy Valley Subdivision South 89°56' East 244.23 feet; thence along the West line of Lot 11 Easy Valley Subdivision and the extension thereof South 0°05'10" West a distance of 249.20 feet, to the Northeast corner of premises described in Volume 563 Page 128 Deed Records of Jackson County, Oregon; thence along the Northerly line of said premises North 76°26'40" West, 150.00 feet, to the Northwest corner thereof; thence along the West line of said premises South 0°05'10" West a distance of 150.00 feet to intersect the northerly line of Stage Road South; thence along said road boundary as follows: North 76°26'40" West a distance of 235.18 feet to an angle point; thence North 76°08'10" West a distance of 29.66 feet to intersect the easterly line of South Columbus Avenue as now surveyed, thence along said East line North 0°05'10" East a distance of 302.28 feet to intersect the westerly projection of the South line of Easy Valley Subdivision, thence along said line South 89°56' East a distance of 159.16 feet to the point of beginning.
