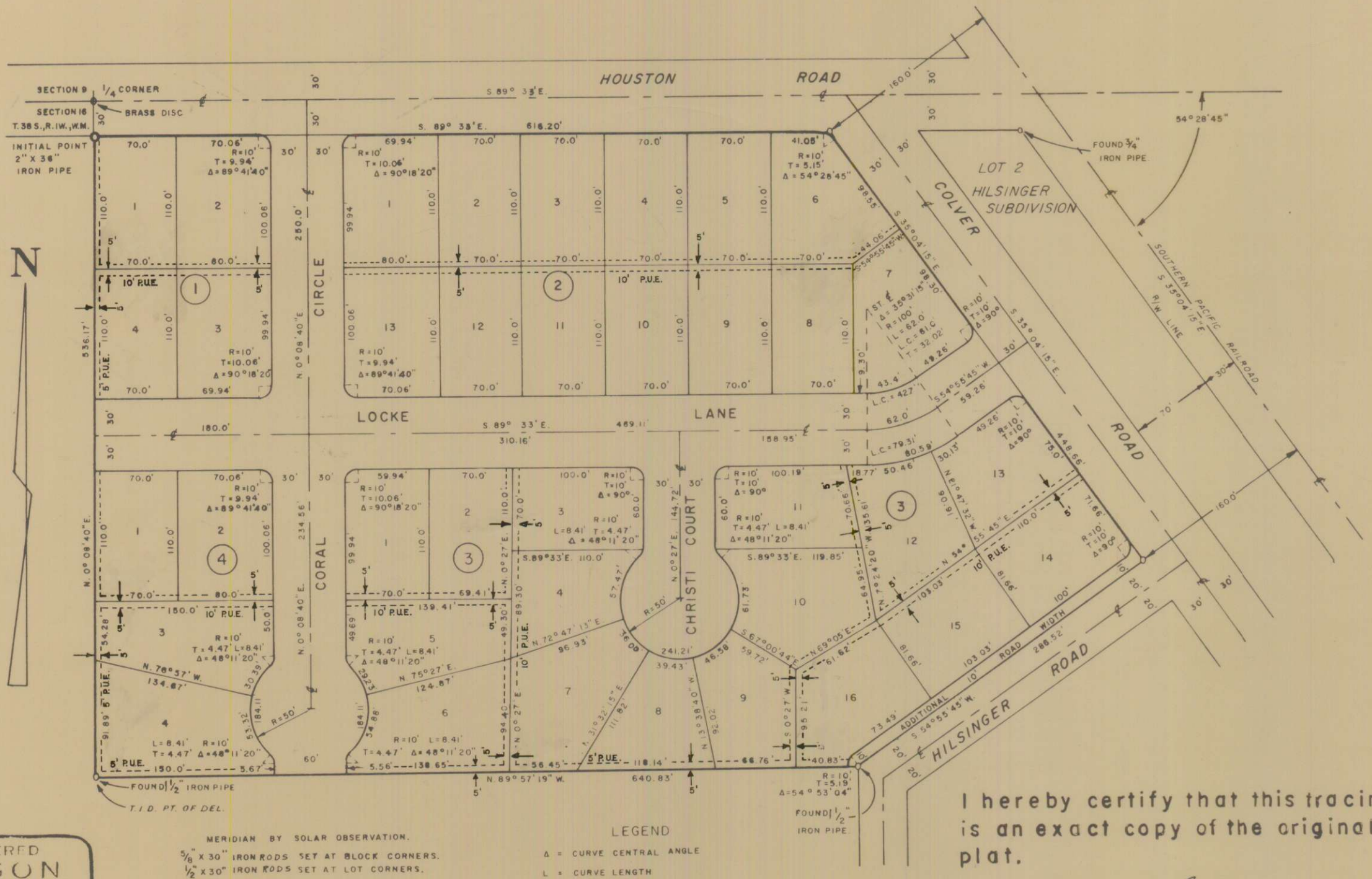
SURVEYOR'S CERTIFICATE

I, L.E. AGER, a duly Registered Surveyor of the State of Oregon, being first duly sworn, do hereby certify that

I have correctly surveyed and marked with the proper monuments as provided by law, the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines: Commencing at the Quarter corner common to Sections 9 and 16, Township 38 South, Range 1 West, Willamette Meridian, Jackson County, Oregon; thence S. 0° 08' 40" W. 30 feet to a 2 inch wide, 36 inch long iron pipe, said pipe being the initial point of beginning and the Northwesterly corner of lot 4 of the *Hilsinger Subdivision* as recorded in Volume 5 page 13 of Plat Records of Jackson County, Oregon; thence S. 89° 33' E. 616.20 feet along the Northerly boundary of lots 3 and 4 of said subdivision to the North-easterly corner of said lot 3; thence S. 35° 04' 15" E. 448.66 feet along the Easterly boundary of lot 3 to the most Easterly corner of lot 3; thence S. 54° 55' 45" W. 286.52 feet to the Northeasterly corner of lot 5 of said subdivision; thence N. 89° 57' 19" W. 640.83 feet along the Southerly boundary of lots 3 and 4 to the Southwesterly corner of lot 4; thence N. 0° 08' 40" E. 536.17 feet along the Westerly boundary of lot 4 to the initial point of beginning.
