

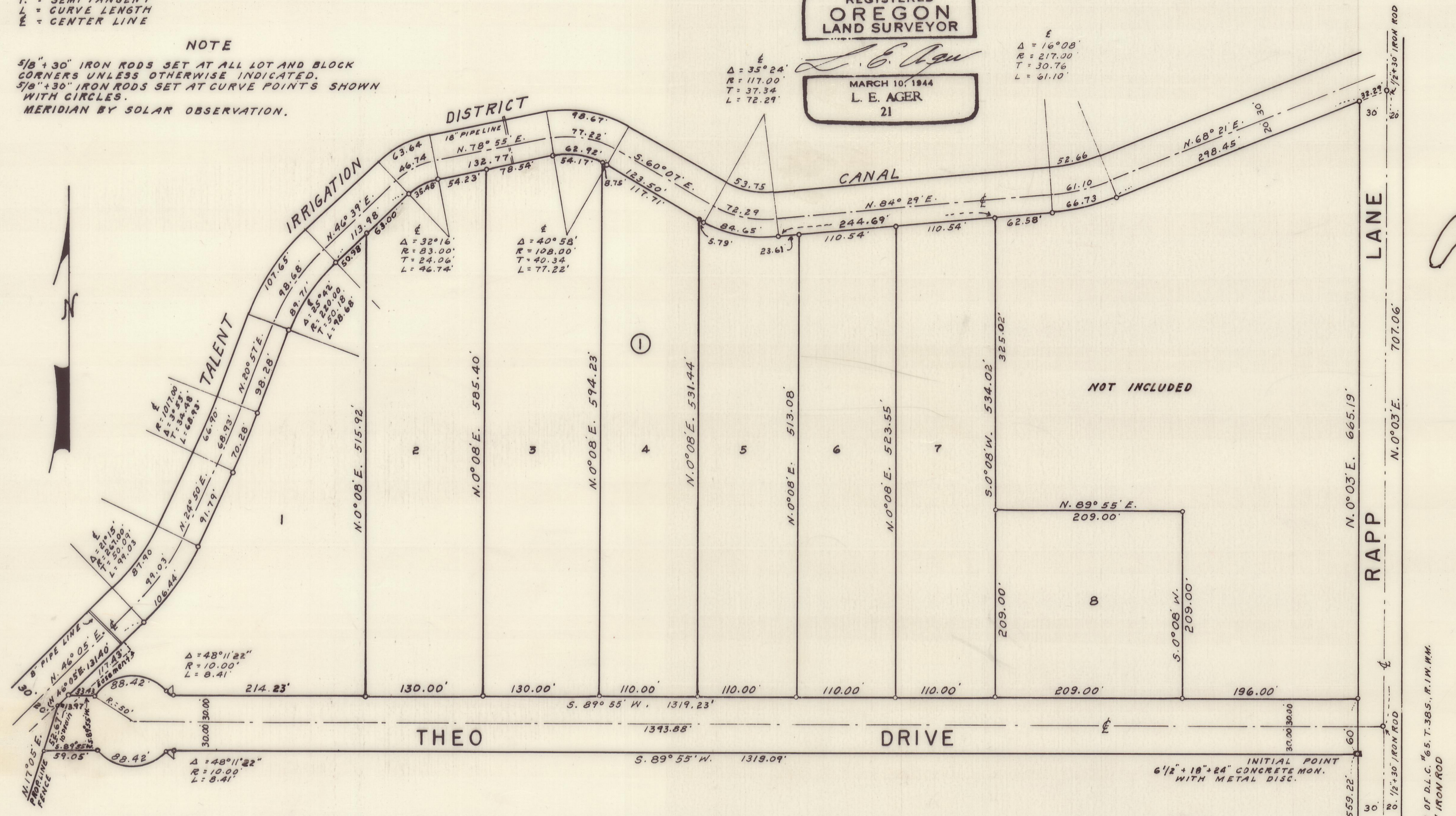
PAMONA HEIGHTS SUBDIVISION

Ager, a duly registered Surveyor of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with proper monuments as provided by law, the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines:

Commencing at a point on the South line of Donation Land Claim No. 65, T. 38 S., R. 1 W., W.M., Jackson County, Oregon, which point is 660.50 feet West of the Southeast corner of said Claim; Thence N. 0° 03' E., parallel with and 30.00 feet Westerly of the Center Line of Rapp Lane, 2559.22 feet to a concrete monument, the initial point of beginning; thence S. 89° 55' W. 1319.09 feet; thence along the arc of a 10.00 foot radius curve left, 8.41 feet; thence along the arc of a 50.00 foot radius curve right, 88.42 feet; thence S. 89° 55' W. 59.05 feet; thence N. 17° 05' E. 52.67 feet to the Easterly right of way line of the Talent Irrigation District Canal; thence along said line as follows: N. 46° 05' E. 131.40 feet; thence on the arc of a 287.00 foot radius curve left, 106.44 feet; thence N. 24° 50' E. 91.79 feet; thence along the arc of a 1037.00 foot radius curve left, 70.28 feet; thence N. 20° 57' E. 98.28 feet; thence on the arc of a 200.00 foot radius curve right, 89.71 feet; thence N. 46° 39' E. 113.98 feet; thence on the arc of a 63.00 foot radius curve right, 35.48 feet; thence N. 78° 55' E. 132.77 feet; thence on the arc of an 88.00 foot radius curve right, 62.92 feet; thence S. 60° 07' E. 123.50 feet; thence on the arc of a 137.00 foot radius curve left, 84.65 feet; thence N. 84° 29' E. 244.69 feet; thence leaving said right of way, a S. 0° 08' W. 325.02 feet; thence N. 89° 55' E. 209.00 feet; thence S. 0° 08' W. 209.00 feet; thence N. 89° 55' E. 196.00 feet; thence S. 0° 03' W. 60.00 feet to the initial point of beginning.
