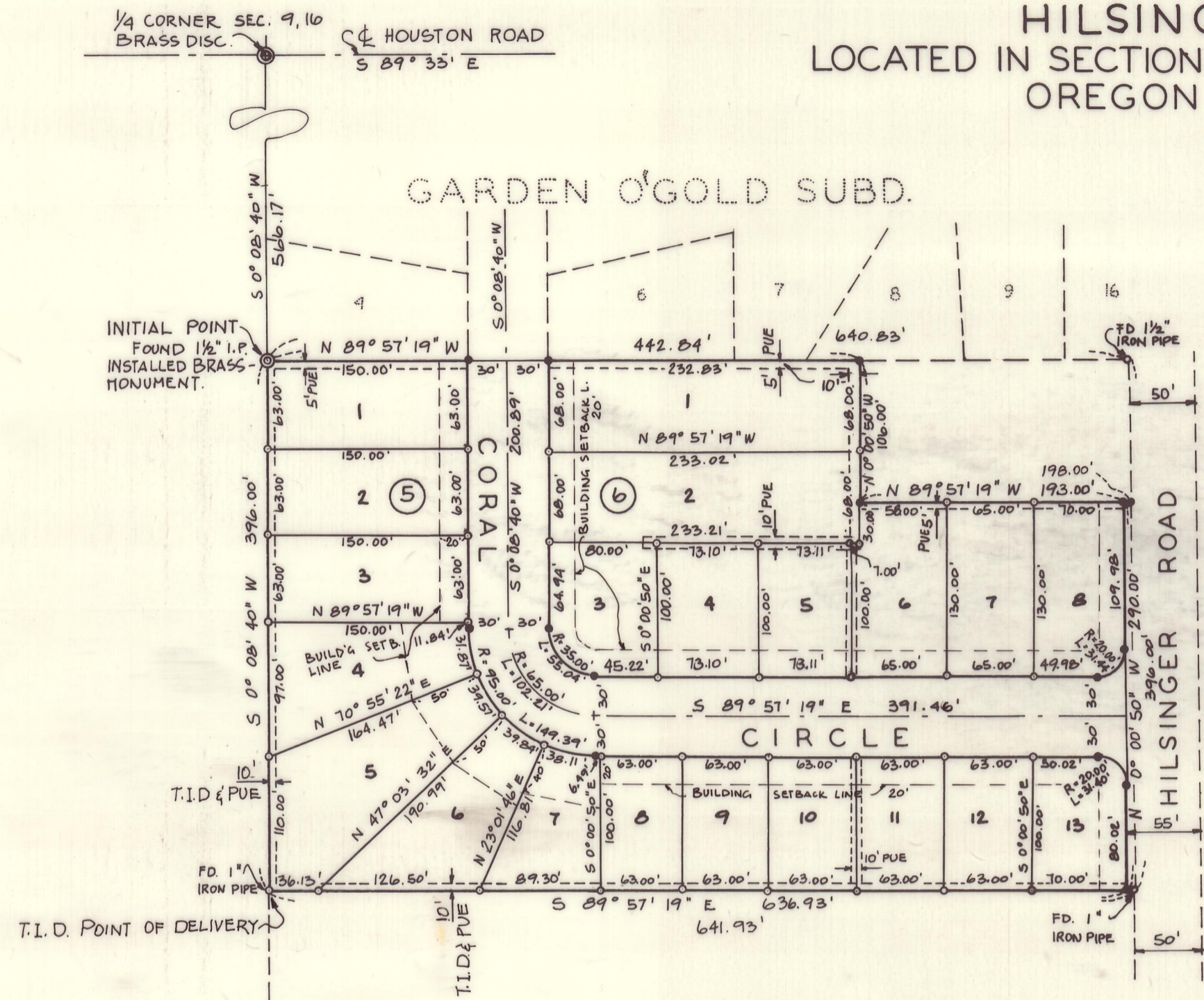


CORAL GARDENS SUBDIVISION

ENGINEER'S CERTIFICATE

I, Bryce W. Townley, a duly registered Engineer of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with proper monuments as provided by law, the tract of land hereon shown and the said plat is a correct representation of the same and the following is an accurate description of the boundary lines:

Commencing at the Quarter Corner common to Sections 9 & 16, Township 38 South, Range 1 West of the Willamette Meridian in Jackson County, Oregon; thence South 0° 08' 40" West 566.17 feet to a brass monument at the initial point of beginning and the northwesterly corner of lot 5 of the Hilsinger Subdivision; thence South 0° 08' 40" West, along the westline of lots 5 and 8 of said subdivision, 396.00 feet; thence South 89° 57' 19" East, parallel with the north line of said lot 5, 641.93 feet to the westline of Hilsinger Road; thence North 0° 00' 50" West along said road, 290.00 feet; thence North 89° 57' 19" West 198.00 feet; thence North 0° 00' 50" West to said northline 106.00 feet; thence North 89° 57' 19" West along said Northline 442.84 feet to the initial point of beginning.
