KNOW ALL MEN BY THESE PRESENTS that we, C.G.O. of Medford-Hilton Heights, a Washington Limited Partnership, and Thada Hilton, owners in fee of the lands hereon described, have subdivided the same into lots and streets, as shown hereon, and the number and size of the lots and lengths of all lines are plainly set forth, and that this plat is a correct representation of the said subdivision, and we do hereby dedicate to the public for public use all the streets as shown hereon, together with all easements as shown hereon, and we hereby grant to the City of Medford in fee simple, those areas portrayed and designated as street plugs. By its approval of this plat, the said City of Medford undertakes that upon the approved dedication of the extension of an affected street, it will deed the street plug for public purposes, and we do hereby designate said subdivision as HILTON HEIGHTS SUBDIVISION.
